2. Programme of the Polish language course includes:

1.1. Two levels of Polish language: A1-A2 - general profile.

1.2. The programme contains the following language units:

- 1) introducing myself – official and unofficial contact, numbers, verbs
- 2) question – what ? co ? nominal case, coniugation, adjectives, singular
- 3) nationalities, professions, question – who are you ? instrumental case, plural
- 4) my family, question – how old are you ? email address, accusative case, numbers
- 5) hobby, question – what do you like to do ? I am interesting in, I like, coniugation
- 6) eating, drinking, food, beverages, in restaurant, fruits and vegetables, how much it costs ?
- 7) activities, days, the numbers, verbs - know, can, go, meet, transportation
- 8) what time, trip, planning a day, I do not like - genitive case – singular
- 9) shopping, clothes, colors, to wear, genitive case – plural, adverbs
- 10) it was, what did you do ? past tense, months, activities in the past
- 11) future tense, what will you do tomorrow, activities in the future
- 12) where are you ? directions, trips, tourist attractions, locative case
- 13) holiday, travelling, tourist offer, to go, to travel, to drive, to ride, to walk, prepositions
- 14) I am looking for a apartment, in apartment, real estates, bying, selling, renting
- 15) wheather, temperature, climate, forecasting
- 16) at the hairdresser, fitness, adjective gradation, appearance
- 17) health, at the doctor, body, diseases, health cases
- 18) birthday, dative case, past, present, future
- 19) sport interesting, movement verbs, numbers, question – whose ?
- 20) post office, map of Warsaw, map of Poland, booking and buying the tickets
- 21) travelling, geography, future tense, connectives, writing
- 22) bying and selling, in the shop, genitive case – plural, adverbs

- 23) business, establishing enterprise, development, working
- 24) money, finance, financing, bank, financial institutions
- 25) work, job, applications, labour market, occupations and professions
- 26) marketing, advertisement, announcement, on-line bying
- 27) organization, position, relations, dative, accusative, genitive
- 28) relax, weekend, holidays in Poland, all tenses, pronouns
- 29) school, university, lecture, lesson, teacher, lecturer
- 30) travelling, transportation, station, international trips

1.3. After completion of the course the participants receive the internal certificate from the Warsaw Economic Institute.

1.4. For international exam and certification of the Polish language for foreigners is authorized the State Commission. The certification (exam) by the State Commission is facultative and at the expense of the course participant.

3. Learning system

- The number of the course hours: 500 (1 course hour = 45 minutes)
- Language of instruction: English
- Place of the course: centre of Warsaw/Nowy Świat Street 49
- Group size: up to 5 participants.
- Learning system: 2-3 x a week

4. Fees:

- registration fee: 250 EUR or equivalent in PLN, paid during application, not refunded if visa will be refused.
- course fee: 2250 EUR or equivalent in PLN, paid within 3 days after visa receiving, and before date of arrival to Poland.

5. Admission process:

- 1) Sending signed application form with scan of the passport to: office@wmsb.edu.pl
- 2) Receipt by e-mail an offer letter. The offer letter is free of charge, is only informative for applicant, and is not a document in visa procedure.
- 3) Payment of the registration fee. The registration fee is not refundable, also if the visa will be refused.
- 4) Issue of the final documents confirming admission to the course (the acceptance letter and proof of payment).
- 5) Payment by the applicant of the course fee within 3 days after visa receiving before the date of arrival to Poland.
- 6) The course fee includes cost of trainer, learning materials for the participants, preparation of the certificate after completion of the course.
- 7) Start of the course.
